#### **RESOLUTION NO. 2021-22**

#### REPORT OF THE EXECUTIVE DIRECTOR

Director Dzema reviewed both his and Lee Mestres written reports and answered several questions.

Commissioner Kreismer motioned to accept the Director's Report as written and presented. Upon a second motion by Commissioner Melanaski the Commissioners unanimously accepted the Director's Report.

The Sayreville Housing for Seniors Corporation was awarded a grant from Sayreville Borough Community Development in the amount of \$70,000 which was committed to the ADA site improvement project at Gillette Manor. The Authority received bids for the project and the low bidder came in at \$143,296.96. The Board discussed moving forward with this project and voted to recommend to the Corporation Trustees approval of the contract and supplementing the project with \$73,296.96 from Corporation reserves.
